**ORDER**

As per the Orders read as 1st paper above, Government have fixed the rate of remuneration to the various staff who are engaged in the Evening Diploma Courses conducted in Polytechnics. As per the letter read as 3rd paper above, the Director of Technical Education has recommended Government to enhance the remuneration to regular faculty who handle the classes for evening diploma course in par with the rate of remuneration of Guest faculty.

Government have examined the proposal in detail, and are pleased to re-fix the rate of remuneration of regular faculty who handle the classes and other staff who are doing related establishment/academic work as follows with effect from 1/1/2014. The Total number of periods and corresponding remuneration shall be limited to that stipulated in the curriculum for a subject/paper.

Government have also verified the income and expenditure in each Polytechnic College on Evening Diploma Courses on the basis of the data provided by the Director of Technical Education. From the data it is seen that the revenue portion deposited in the Government account is very meagre compared to the income of the Course. But the whole establishment and infrastructure for conducting the course are provided by Government. As such revenue portion needs to be increased in par with the income of the Course.

In the circumstances, the admission fees collected so far shall be remitted to the revenue account immediately. The Director of Technical Education shall submit proposal for increasing revenue portion from the next academic year in the proposal of Prospectus.
