Higher Education- Technical - Extending the benefit of Compassionate Employment Schem to the employees of Aided Polytehnic Colleges - Kerala Technical Education (Privat Engineering Colleges/Polytechnics) Rules - Amended - Orders Issued.

#### ORDER

Government hereby issue the following amendments to the Education (Private Engineering Colleges/Polytechnics) Rules read as 1st paper above for enabling to make appointment under Compassionate Employment Scheme to employees i Aided Polytechnic Colleges.

- (1) In PART II Rule 3 under the heading "Conditions of service" the following shall b substituted
  - 1. (1) Provided further that Compassionate Employment Scheme for dependants ( Private Polytechnic College (Aided) service who die-in-harness as contemplated i G.O.(Ms)No.317/2011/H.Edn dated 26.11.2011 should be applicable for the first 5. percent of vacancies/subject to a minimum of one post in a year subject to thes conditions:

Date of effect: The amendment to these Rules shall have effect only from 26.11.2011 i.e. from the date of issuance of G.O.(Ms)317/11/H.Edn.

Eligibility: Applications from dependents of employee who die in harness will b considered for employment assistance under the scheme. Employees shall includ Contingent and Work Establishment personnel, Part-time employees and N.M.F. Workers.

Family Income: The maximum income of the family of the deceased employee shoul not exceed Rs.4,50,000/- (Rupees Four lakhs and fifty thousand only) per annum t make dependent eligible for the Compassionate Employment and this limit will be revised from time to time on the basis of the order of Personnel & Administrative Reforms Department in the case of Compassionate Employment Scheme for the Government Servants.

Family Income to be reckoned on the basis of the rules and orders issued by Personnel and Administrative Reforms Department from time to time. Income certificate shall be obtained from the revenue authorities concerned. In case of disputes on income, the case shall be referred to the concerned District Collector and the income reported by the Collector shall be accepted as the actual income.

Dependents: (a)Only one dependent will be given employment assistance under the scheme in the event of the death of an employee. Employment assistance shall be given to the widow/widower, son, daughter in the said order of priority. Son an daughter shall include adopted son and adopted daughter, respectively and will ran after son/daughter.

However, in the case of unmarried Employee dying in harness, Father/Mothe Unmarried Sister/Unmarried Brother shall also be eligible for employment assistance.

No other dependent shall be eligible for giving appointment under the Schemi (b)Whenever there is a dispute between the claim of two dependents, the person recommended by the widow/widower of the deceased employee will be preferred.

(c) In the case of dependents other than widow/widower, the consent of t widow/widower shall invariably be obtained.

Category of Appointment: Appointment shall be made in the post Demonstrator/equivalent to that of Demonstrator or a post lower than that Demonstrator on the basis of qualifications.

Qualification for posts: The qualification prescribed for direct recruitment to the post apply. No relaxation in the qualifications will be allowed under the scheme.

Age Limit: In the case of appointment to widow/widower and in the case Father/Mother of unmarried employee who die in harness and in the case appointment to part-time contingent posts, there shall be no upper age restriction, applicants shall be given appointment up to the age of retirement. In all other case the upper age limit prescribed for direct recruitment to the post shall apply.

<u>Time limit for preferring Application</u>: The time limit for preferring application under the scheme will be 5 years from the date of death of employees. In the case of minor, the period will be within 3 years after attaining majority.

Appointing Authority: The Manager of the concerned Institution is the authority t appoint the person under the scheme. But the Manager shall obtain approval of the Director of Technical Education within three months from the date of appointment. The Director of Technical Education can deny approval on the ground that the appointment is against the rules herein or any other relevant rules applicable in the case. The reason for rejection shall specifically be mentioned in the order of the Director of Technical Education.
